## **Faceless No Objection Certificate Service Process Flow**



# Important Points to note for availing No Objection Certificate Service

**Who can apply:** Only for Maharashtra registered vehicles, moving outside Maharashtra, complying all conditions mentioned below:

1. Individual Ownership
2. Non-Transport Vehicle
3. Non-Hypothecated Vehicle
4. Vehicle owner full name in Vahan records matches exactly with full name mentioned in Aadhaar records
5. Vehicle owner's mobile number in Vahan records matches exactly with mobile number linked to Aadhaar
6. Vehicle owner's current address pin code in Vahan records matches exactly with pin code of address linked to Aadhaar

**Documents Required:**

1. Self attested ID proof of the Applicant
2. Photograph of the Vehicle from front
3. Photograph of the Vehicle Chassis No.
4. NCRB Vehicle NOC Certificate
5. Vehicle Registration Certificate Copy

## **Process flow:**

- Aadhaar Authentication
- Online Form Filling
- Document upload – All documents to be mandatorily uploaded
- Application Submission
- RTO Verification and Approval
- Printing of No Objection Certificate from Vahan citizen interface
